2017 School Board Elections reminder

Elections to be held on Monday, October 16. Nomination day is 4 weeks prior to election day which will be Monday, Sept. 18. More information is available on the ASBA (Alberta School Boards Association) website.

The new RVS ward boundaries will come into effect then.

RVS Budget

The Board of Trustees will be presented the draft budget on May 18, voting on the RVS budget for 2017/18 on June 2.

Although we face many funding challenges one of the biggest is in the transportation budget. To offset about a million dollar deficit the board has set the transportation fees for the 2017/18 school year.

RVS Transportation Fees

Bill 1 – An Act to Reduce School Fees will cover transportation fees for those students who live more than 2.4 km from their designated school.

Due to about a million dollar transportation deficit the board reluctantly moved to increase fees for riders not covered under Bill 1. These riders live less than 2.4 km from their designated school or attend a program of choice at a non- designated school.

The fee increase will range from \$95 to \$105.

Alberta Curriculum feedback opportunity

There is now a second opportunity for Albertans to give feedback on curriculum development. A survey is open on the Alberta Education website until June 2. Dual Credit Funding Announced

Alberta Education has announced a commitment of \$16.4 million for Alberta's Dual Credit program over the next four years. Aimed at expanding the program by up to 40 new start-up programs annually, the new funding model offers predictable sustainable funding that will help school authorities provide learning opportunities to reflect the needs and interests of their students, school and community. School authorities may offer Dual Credit opportunities through a variety of environments, such as distributed learning, blended learning and e-learning. An application process for start-up funding is anticipated and will be released in the fall.

RVS Annual Satisfaction Survey

Rocky View Schools' eighth annual Satisfaction Survey will be open to students, staff and parents until May 31. We appreciate those of you who take the time to respond as it helps to identify needs. The data is included in the School Annual Reports.

Growth In Springbank

As reported earlier in the year, we are starting to see the impact of growth in RVS on the community of Springbank. For a number of years we have been able to welcome and accommodate families from outside the school division based on "room and resources".

Alberta Education considers schools to be full at 85% capacity, and we are now over that number at SMS. Unfortunately that means that we cannot accommodate students from outside the jurisdiction at SMS.

I would personally like to thank those parents who have contributed to our Springbank schools. It has been a pleasure having you at Springbank and we wish you much success.
