School Council- Principal's Report for October 17th, 2018

1. **Staffing Changes:** We are pleased to welcome Jay Peterson who will be covering Sara Syme's maternity leave and Parvis Ramirez who will be covering Nashira Dernesch's leave.
2. **Career Week** was a big success with over 50 presenters coming to the school to share their story with our students. Thanks to Carla Cochran for organizing.
3. **Vaping Procedures:** Due to an increase in the number of vaping incidences, we have decided to take a stronger position in trying to deter this behaviour. Rockyview Schools has already outlined policy on smoke free/tobacco free/ e-cigarette free environments and so we are enforcing policy already in place. As a school, we have decided to issue 3 day out of school suspensions for students caught vaping or being in possession of vaping paraphernalia on school property. This was outlined in communication that was emailed directly to parents, was shared with students in advisory and was also sent in our Phoenix Flyer. We have had numerous positive emails of support from parents for taking this stance. Our intent is to support students in making sound, wise and healthy decisions and our discipline procedures will reflect the education and support aspects of our interventions.
4. **Art Therapy-** we have contracted WP Puppet Theatre to come in and work with some of our students through their Behind the Mask program. This program will help students reflect on mental health issues and provides a venue for support and exploration of any mental health challenges they may be experiencing. Program coordinators will be working with Kara Bonikowsky, Pam Smid and Erin Tysowski once a week from October to December.
5. **Addictions Counselor-** through a pilot partnership with AHS, we will have an addictions counsellor available one day per week to provide education, support and counselling to our students. Working with our admin and guidance department, we will have the counselor work with advisory classes, CALM classes, Focus sessions and assist with re-entry for those cases that directly relate to addictions. We are excited for this valuable resource to be a part of our community.

October Report Trustee Hunter - Ward 5

Great News!! Through the collective efforts of parents, students and Rocky View Transportation Department, the Board has achieved its goal of reducing the transportation budget by approximately one million dollars. The Board of Trustees is thankful to all of the parents who participated in our survey helping to create the least disruptive plan to achieve this savings.

The enrolment for Rockyview Schools has increased by over 900 students. The School Division desperately needs new schools and is advocating hard on behalf of our parents and students. Rockyview Schools continues to grow at approximately 5% per year. New school construction has not kept pace. The Board has worked with some of our schools to adjust boundaries to alleviate enrolment stress but this is only a temporary solution. Across the division we are in need two new schools per year. Last year were given zero. To boot, we did not receive all of the portables that were requested. A new school takes approximately three years to build. I would encourage all parents to be aware of school capacity needs in their communities so that schools are in place when the need is present. Parents need to let government know of their concerns in this matter.

A shout-out to Jenny Hawryluk who won top pop song of the year at the Calgary Music Awards September 21, 2018. Jenny is attending Springbank High School.

I had the privilege of attending the Academic Awards Assembly at Springbank High School. It was a lovely event recognizing the success of so many Springbank High Schools students achieving excellence both academically and with citizenship.

This fall schools sponsored a "Run for Terry Fox". It is wonderful to see the next generation learn about and celebrate the legacy of this Canadian hero.

RE: Cannabis In RVS

What We Know About Cannabis

- Regular cannabis use in adolescents is associated with experiencing psychotic symptoms (changes in thoughts, feelings and behaviours), especially when there is a family or personal history of psychotic disorders. Some studies have suggested that cannabis may also increase risk of anxiety and depression.
- Early and frequent cannabis use is linked with poor performance in school, lower grades and increased risk of dropping out. Some research suggests that early, regular, heavy and long-term use of cannabis by teens may impair their cognitive abilities and may not be fully reversible
- Youth might be particularly vulnerable to these negative outcomes due to the extensive changes that are taking place in the brain during adolescence, especially the ongoing development and maturation of the prefrontal cortex, which is critical to higher-order cognitive processes such as impulse control, working memory, planning, problem solving and emotional regulation.

How RVS is Preparing for the Legalization of Cannabis

- RVS reviewed its current procedures to ensure they state that RVS clearly prohibits the possession and use of alcohol and drugs by all students, staff, and community members while on Board property, school buses, and while attending school and at Board-sponsored events. Staff and students that violate this procedure will be subject discipline as outlined in Administrative Procedure 350 Student

Discipline or 410 Employee Progressive Discipline.

- As part of its Social Emotional Learning initiative, RVS will incorporate the detrimental effects of cannabis use among youth.

Where Can Teachers and Parents Find Help

- Parents are a child's best defense against drug use. The top two things that a parent or guardian can do is to be informed about drug issues and talk to your kids about drugs.
